# 1. Description of the academic discipline

## 3. The purpose and tasks of the educational discipline 2.1. The purpose of discipline

The purpose of teaching the educational discipline "Legal foundations of professional activity" is to form in students an in-depth understanding of the main legal concepts and categories necessary for them in the implementation of professional activity, to master modern necessary legal tools for the protection of labor and copyright rights of choreographers, guarantees of their social protection, etc.

## 2.2. Tasks of the discipline

The main tasks of studying the discipline "Legal foundations of professional activity" are: repetition of basic knowledge in jurisprudence regarding the sources of legal regulation of labor and personal non-property relations, in particular the Code of Labor Laws of Ukraine, the Civil Code of Ukraine and regulatory legal acts in the field of labor protection, acquisition of special knowledge from certain provisions of civil and labor law. The program also provides for a more in-depth study of issues related to social insurance and the investigation of accidents and occupational diseases of choreographers, which allows taking into account the specifics of the study of students in the "Choreography" specialty.

## 2.3. Expected results

The student must know: the system of sources of legal regulation of labor and personal non-property relations, the concept and content of an employment contract, the concept and methods of copyright protection, the features of social insurance against accidents and occupational diseases.

**The student must be able to**: navigate the basic legal requirements regarding the professional activity of choreographers, correctly apply legal norms in the field of labor protection and the exercise and protection of copyright for a choreographic performance and related performance rights.Програма навчальної дисципліни

## Program of the discipline.

The educational material of the discipline is structured modularly and consists of two training modules , namely:

## **MODULE I.**

## **Topics of lectures.**

**Topic 1. Legal regulation of labor relations of choreographers.** 

Emergence of labor relations of choreographers. Grounds for the emergence of labor relations. Conclusion of an employment contract. The form and content of the employment contract. Terms of the employment contract. Testing for employment. Employment history.

Topic 2. Legal provision of working time and rest time. Pay.

Norm of duration of working hours. Flexible mode of working hours of artists. Summarized record of working hours of artists. Duration of work at night. Rest time. Weekend. Holidays and non-working days. Payment for work on holidays and non-working days.

Annual vacations. Monetary compensation for unused annual leave. Leave without pay. Salary. Minimum wage. Wage indexation.

Payment for part-time work. Terms of payment of wages.

#### **Topic 3. Termination of the employment contract.**

Grounds for termination of the employment contract. Termination of an employment contract concluded for an indefinite period at the initiative of the employee. Termination of a fixed-term employment contract at the initiative of the employee. Termination of the employment contract at the initiative of the owner or a body authorized by him. The commission of an immoral act by an employee performing educational functions, which is not compatible with the continuation of this work, as an additional reason for terminating the employment contract at the initiative of the owner with certain categories of employees under certain conditions.

Preferential right to remain at work when employees are dismissed due to changes in the organization of production and work. Exit assistance.

Termination of the employment contract at the initiative of the owner or a body authorized by him with the prior consent of the elected body of the primary trade union organization (trade union representative).

**Topic 4. Legal provision of labor protection of choreographers and artists.** General characteristics of regulatory and legal provision of labor protection. Traumatism and professional diseases of artists. Accidents: concepts and types.

Accident investigation procedure. Investigation and accounting of occupational diseases. Social insurance against accidents at work and occupational diseases. The Social Insurance Fund for Industrial Accidents and Occupational Diseases of Ukraine. Insurance benefits in connection with accidents and occupational diseases.

Retirement of artists. The right of artists to a pension for years of service.

#### **Topic 7. Intellectual property right.**

Concepts and types of intellectual property rights. Objects and subjects of intellectual property law. Personal non-property intellectual property rights. Property rights of intellectual property. State system of legal protection of intellectual property. Purpose and principles of legal protection of intellectual property rights.
